HMAS Canberra I Memorial Service

The ACT Section commemorated the 77th anniversary of the loss of the first HMAS *Canberra* on 9 August 2019 honouring the 84 men of the Royal Australian, Royal and United States Navies, and the Royal Australian Air Force who were killed in action or subsequently died of their wounds. The loss of more than 1,200 American casualties in the USN ships which were engaged in the Battle of Savo Island was also remembered.

Unfortunately due to the weather forecast of rain and the strong winds that were experienced that morning, a Wet Weather routine was implemented and the service was cut short.

Members of HMAS *Canberra* III ship's company were able to attend and it was a great mark that her present Commanding Officer and two of his predecessors were at the ceremony. CDRE Smith *Canberra's* 2nd CO represented the Chief of Navy at the ceremony and laid a wreath on behalf of the RAN. CAPT Morrison laid a wreath on behalf of his ship's company.

Those hardy people who attended the ceremony got together afterwards in Poppy's Cafe at the AWM for a sheltered coffee and lunch.

AWM Director thanked for outstanding achievements

The Hon Darren Chester MP Minister for Veterans and Defence Personnel

THE Federal Government will undertake a nationwide search for a new director of the Australian War Memorial after Dr Brendan Nelson AO has announced that he would finish in the role at the end of the year.

After seven years as Director, Dr Nelson told Australian War Memorial staff this morning that he will conclude his service when his appointment ceases at the end of the year.

Minister for Veterans and Defence Personnel Darren Chester thanked Dr Nelson for his passion and outstanding contribution to honouring the service and sacrifice of the almost two million people who have served in wars, conflicts and peacekeeping operations.

"Brendan has provided leadership to the Memorial that has made it world-renowned, including managing its extensive upgrades and overseeing the Centenary of Anzac program," Mr Chester said.

"Having previously served as Minister for Defence, Brendan's passion for telling the stories of service and sacrifice of current and former Australian Defence Force personnel of more recent conflicts has been extraordinary.

"Under his guidance, the Memorial has also led a range of exhibitions, displays, memorials and documentaries of our First World War, Korean and Vietnam conflicts, and more recently, the commemorations of the Centenary of the First World War, including the poignant display of 62,000 knitted Poppies.

"More recently, I worked closely with Brendan and the Council of the Australian War Memorial to secure a \$498 million investment to expand the Memorial for future generations, which will ensure all Australians who have served in our armed forces are honoured and that their stories are told.

"However, his most important achievement is the solemn and respectful Last Post Ceremony held at the Memorial each night. It was Brendan's vision to have this brought to the Memorial, which is inspired by the daily ceremony held at the Menin Gate Memorial to the Missing in Ypres, Belgium.

"I commend Brendan on his passion and commitment to commemorating the service and sacrifice of all Australians who have served our nation. His enthusiasm and leadership will be missed and I wish him all the best for the future."

In 2016, Dr Nelson was appointed an Officer of the Order of Australia for his services to the Parliament of Australia, to the community, to the advancement of Australian international relations and to major cultural institutions. Dr Nelson has also been conferred Honorary Life Membership by the Returned and Services League of Australia.

Mr Kerry Stokes AC Chair of the Australian War Memorial Council, also thanked Dr Nelson for his dedicated service. "Dr Nelson has overseen a transformation in the Australian War Memorial that has taken it to a new level of awareness and appreciation by the Australian people."

"Working closely with the Memorial's Council and building on the work of his predecessors, Brendan has brought our nation's history to life, emphasised the commemorative and healing role of the Memorial and most importantly, made it a place of immense meaning for young servicemen, women, veterans and their families."

"The generational investment by the Morrison government to grow the Memorial and allow the more stories of 100,000 young veterans will be his enduring legacy."

A recruitment process will commence shortly to appoint the new Director of the Australian War Memorial.

Commander Joint Task Force 633 Air Vice-Marshal Joe Lervasi has officially handed over command of Australian Defence Force operations in the Middle East region.



The command was passed to Rear Admiral Mark Hill at a transfer of authority ceremony on June 28 at Australia's main operating base in the region.

Air Vice-Marshal Lervasi said he had observed an evolution in Australian operations across the Middle East.

"Both the train, advise, assist mission in Afghanistan and the build partner capacity operation in Iraq are achieving milestones," Air Vice-Marshal Lervasi said.

"We have seen, in both Afghanistan and Iraq, their military no longer just receiving training but taking the lead in training themselves."

Air Vice-Marshal Lervasi said the rest of the world had witnessed what Australia brought to the region.

"Australia contributes here in meaningful ways and, more importantly, we come here without vested interests and with the genuine intent of making the situation better," he said.

Minister for Veterans and Defence Personnel Darren Chester said he was delighted that Army veteran and current Chief Executive of BAE Systems Australia, Ms Gabby Costigan, had agreed to chair the new Council.

"I look forward to working with such a talented and experienced group of individuals to help provide a stronger voice for an often unheard part of the community."

HMAS *Arunta* completes AMCAP

HMAS *Arunta* has recently returned to Fleet Base West after a 20-month Anzac Midlife Capability Assurance Program (AMCAP) upgrade which includes a platform systems remediation program to improve platform reliability and maintainability. *Arunta* is the first FFH to undergo the program which provides significant improvements to the ship's key sensor and communications systems.



The Project SEA 1448 Phase 4B component of the upgrade improves the Anzac class Air Search capability by replacing the AN/SPS-49 long range air search radar with a new digital CEAFA2-L phased

array radar developed by Australian company CEA Technologies.

Fire in the hole

HMAS *Hobart* conducted sea trails on ships systems before the commencement of their Unit Readiness Evaluation (URE), a vital step to prove the capability of the ship and crew before proceeding on deployment.

A mix of senior officers, APS personnel and industry representatives from across ship building pro-

jects joined the ship to familiarise themselves with the capability of the Air Warfare Destroyer and its integration with future technologies.

HMAS Hobart conducts a live fire exercise using the vertically launched RIM-66 Standard Missile 2 (SM2) as a test of capability before proceeding to their Unit Readiness Evaluation (URE).



Warm reception for Flag Ship's return

Hundreds of family and friends welcomed HMAS Canberra home on 5 August following her six month overseas deployment through Asia.

The ship's 388-strong tri-service company lined the upper decks as she pulled alongside Garden Island before stepping ashore to greet their loved ones for the first time since leaving Australia in February.

The 230 metre long Landing Helicopter Dock sailed almost 22,000 nautical miles during the deployment, visiting Sri Lanka, India, Malaysia, Thailand, Vietnam, Singapore and Indonesia as part of the international engagement exercise INDO-PACIFIC ENDEAVOUR 2019.

During this phase of the deployment, *Canberra* participated in the bilateral maritime exercise AUSIN-DEX with the Indian Navy, conducted the first passage exercise between the Royal Australian Navy and the Vietnamese People's Navy and supported the International Maritime Defence Expo 2019 in Singapore.

She also played a key role in Exercise OCEAN EXPLORER and the Joint Warfare Series, encompassing Exercise SEA EXPLORER, Sea RAIDER and TALISMAN SABRE 2019.

Canberra was home to more than 1400 people during different phases of her deployment with 430,000 meals served to her permanent ship's company and embarked forces from around the world.

Chief of Navy, Vice Admiral Michael Noonan was on the wharf as *Canberra* arrived and said that the

ship's company had achieved many key milestone in international engagement and amphibious capability.

HMAS *Canberra* has proven she is a versatile platform, able to lead multi-ship Task Groups to engage with our regional partners far from Australia, as well as played a key role in successful multinational exercises.

"Working with our neighbours is vital to maintaining interoperability and protecting our common interests in promoting peace and stability in the region," Vice Admiral Noonan said.

Commanding Officer of HMAS *Canberra*, Captain Terry Morrison said the deployment had been demanding but his ship's company had met the challenge with enthusiasm.

"A deployment as long and far away as this can be hard work, but I am proud of the crew for their hard work and consistently representing the Royal Australian Navy as a professional force everywhere we sailed.

"I thank the families and friends of our ship's company for supporting their loved ones while they've been deployed.

"Know you can be proud of how they have represented Australia these past six months away from home," he said.

A diverse and wide-ranging career has led to many positive challenges for the new Commanding Officer of HMAS *Harman*.

"It's pleasing to be able to say that this is increasingly the norm," Commander Howard said.

"We should all be able to balance service and family, no matter what the member's rank, age or family circumstances.

"I'm very thankful that the Navy provides access to a vast range of personal and organisational services that have supported me to balance family and career commitments."

Having joined the Royal Australian Navy in 1996 as a 17-year-old, Commander Howard has seen many changes throughout her Royal Australian Navy ser-

"These progressive opportunities, which are for all Navy personnel, will continue to be a driving need to support current and future capabilities," Commander Howard said.

"It is truly the distinguishing aspect of our 'job'.

"But, don't just live in the here and now, think of where you want to be in 10 years and seek out different opportunities to achieve that goal," she said.

Commander Howard was surrounded by family at her transfer of command ceremony, with her husband Simon, children Brianna, Erin and Mitchell, and her parents Ray and Lucy in attendance.

"My entire family have all influenced the person that I am today and I thank them for their love and support," she said.

Open Arms retains mental health accreditation

Veteran-specific lifeline *Open Arms – Veterans and Families Counselling* has successfully retained its Mental Health Accreditation under the National Standards for Mental Health Services (NSMHS).

Minister for Veterans and Defence Personnel, Darren Chester, has welcomed the decision, made this week, saying the service provides an invaluable counselling support service to veterans and their families.

“Accreditation follows a rigorous assessment process conducted by an independent, external assessing agency, Quality Innovation Performance Limited (QIP),” Mr Chester said.

“QIP’s accreditation report stated that Open Arms had met all requirements of the NSMHS and commended Open Arms on its many strengths and positive feedback from clients and stakeholders.”

Mr Chester said comments made from veterans and their families about Open Arms included:

- *The help they gave me early on probably saved my life – now they’re keeping me stable*
- *I feel it’s safe because it’s a public service organisation. They understand military context – it makes the world of difference*

- *They were and are a lifesaver*
- *The staff are skilled and genuinely concerned about me and my family*
- *Helped me understand what my partner was going through with PTSD and why they acted the way they did*
- *I felt very validated and supported*
- *They have an understanding that we’re constantly in fight mode...they get it and they understand that, it’s respectful*
- *I find the service very easy to get to.*

“The Government is committed to putting veterans and their families first — their mental health and wellbeing is a top priority,” Mr Chester said.

“Mental health is everyone’s business – families, friends, employers, community organisations and the Ex-service Organisations all have an important role to play in supporting veterans and their families.

“I encourage any veterans—or their family member—who are struggling with their mental health to reach out for support.

“You are not alone; support is available whenever you need it. Free and confidential help is available through Open Arms and available 24/7, 365 days a year. Open Arms can be contacted on 1800 011 046.”

Not us': Push for new ACT coat of arms gathers momentum

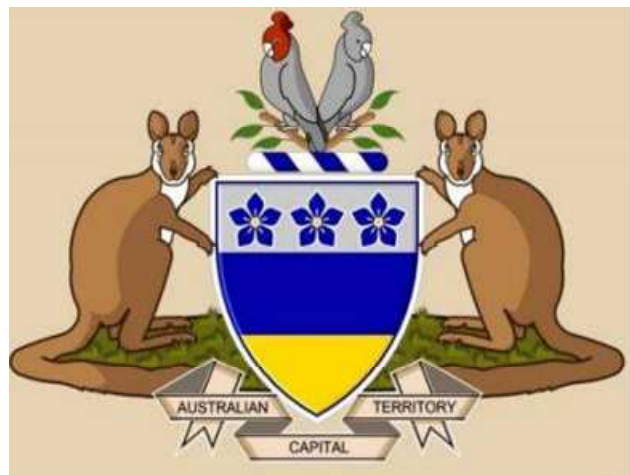

The push for a new Canberra coat of arms is gathering momentum, with a report showing the 91-year-old crest is widely viewed as "anachronistic" and "unreflective" of the modern-day ACT.

The Assembly committee inquiring into the city's heraldry handed down its final report on Thursday, recommending the government either adopt a new coat of arms or update the existing emblem.

The government should also heed the "widespread displeasure" with the ACT flag and design a new one, the committee recommended.

Alternative coat of arms designs which featured the ACT's floral emblem, the royal bluebell, and new mammal emblem, the southern brush-tailed rock-wallaby, were presented to the committee as part of the inquiry.

AGE-FRIENDLY CANBERRA—A VISION FOR OUR CITY

Gordon Ramsay, the Minister for Seniors and Veterans discussed with National Seniors ACT Policy Advisory Group (PAG) the development of an aged-friendly Canberra for the future. The framework for this is being developed and will become Government policy in early 2020. He intends to further consult with us in November when more consultations have been completed. The initial proposal was developed in conjunction with the Ministerial Council on Ageing. Here is some of the document

“VISION STATEMENT Older Canberrans are recognized as valued members of our community and enabled to lead productive and active lives as they age.

12 key principles have been suggested as a basis for the plan. These include:

- ***The contribution that older people make to the Canberra community is valued and recognized.***
- ***Older people are consulted and empowered. The voice of older people is heard in policy development and delivery.***
- ***The abuse of older people in any form is not tolerated. The protection of older people from any form of abuse is a priority and is paramount.***
- ***The city's services meet the specific needs of older people.”***

When these principles are confirmed an action plan will be developed that will be used as the basis for action Canberra wide and to inform budget decisions.

It appears to PAG to be an extremely worthwhile proposal and deserves our support and we look forward to further consultations with the Minister. Of course, the devil will be in the detail and in what actually happens on the ground. But we can hope.

We will keep you informed over the next 6 months.
