### **NUSHIP** Arafura launched

The first of 12 Arafura-class offshore patrol vessels - NUSHIP *Arafura* was been launched at the Osborne Naval Shipyard in South Australia on 17 December 2021.

First Assistant Secretary Ships Division, Sheryl Lutz, said the Arafura-class offshore patrol vessels were one of the foundational projects in the 2017 Naval Shipbuilding Plan.

"Luerssen Australia is contracted to build 12 offshore patrol vessels, two at Osborne Naval Shipyard in South Australia and 10 at Henderson Maritime Precinct in Western Australia.," Ms Lutz said.

Building the first two OPVs in South Australia enabled experienced shipbuilders from the Hobart-class destrover to be

retained and then transitioned to the new Hunterclass frigates, setting the foundation for a continuous sovereign naval shipbuilding industry.

The 80-metre long OPVs will primarily undertake constabulary missions and maritime patrol and response duties.

They will incorporate state-of-the art sensors and command and communications systems, improving operational capability alongside Australian Border

Force vessels, other Australian Defence Force units and Australia's regional partners.

Minister for Defence Peter Dutton said the functions undertaken by the patrol boat were becoming increasingly important.

"As we enter a period of unprecedented regional instability and uncertainty, we again forge ahead with this new capability and with new confidence," Minister Dutton said.

"By 2030, the shipbuilding workforce will grow to over 2000 here at Osborne as part of the 15,000 workers directly employed under the government's Naval Shipbuilding Plan.

"These numbers speak obviously of our commitment to building our Navy's strength to develop our sovereign industrial capabilities and to grow our Naval Shipbuilding Enterprise."

#### NATIONAL CABINET STATEMENT

National Cabinet met today to discuss our response to COVID-19 and the Omicron variant, new approaches to test, trace isolate and quarantine including the use of rapid antigen tests (RATS) and the vaccine rollout and booster programme.

The Chief Medical Officer Professor Paul Kelly provided an update on the spread of the Omicron variant. Omicron case numbers continue to increase in Australia and globally. Omicron continues to show greater infectivity than the Delta variant, but with less severity.

Since the beginning of the pandemic there have been 612,106 confirmed cases in Australia and, sadly, 2,289 people have died. More than 56 million tests have been undertaken, with 1,643,841 million tests reported in the past 7 days.

Globally there have been over 294.9 million cases and sadly over 5.4 million deaths, with 2.6 million new cases and 7,169 deaths reported in the last 24 hours. The COVID-19 pandemic continues to surge in many countries around the world.

National Cabinet received a detailed update on Australia's COVID-19 vaccination program from Lieutenant General John Frewen, Coordinator General of Operation COVID Shield.

Australia's COVID-19 vaccine roll out continues to expand. To date 43 million doses of COVID-19 vaccines have been administered in Australia, including 212,497 in the previous 24 hours.

In the previous 7 days, more than 754,500 vaccines have been administered in Australia. More than 94.5 per cent of the Australian population aged 16 years and over have now had a first dose of a COVID-19 vaccine, including 98.7 per cent of Australians aged 50 years of age and over and more than 99 per cent of Australians aged 70 years of age and over.

More than 91.6 per cent of Australians aged 16 years and over are now fully vaccinated including more than 96.8 per cent of Australians aged 50 years of age and over and more than 99 per cent of Australians aged 70 years of age and over.

Over 2.7 million booster doses have been administered. Australia has sufficient supplies of boosters, with nearly 18 million mRNA vaccines in stock in Australia. Yesterday, over 176,000 boosters were administered across Australia. Following the widening of eligibility for boosters on 4 January to those who had their second dose at least four months earlier, over 33.8 per cent of those eligible for boosters have had a booster and 28.6 per cent of Australians aged 70 years of age and over have had a booster in the last 8 weeks since the booster program commenced.

National Cabinet will meet again on Thursday 13 January 2022.

#### Rapid Antigen Tests

National Cabinet noted that COVID-J.9 tests are free and available at state testing clinics for people who have symptoms or are a close contact.

National Cabinet agreed that up to 10 Rapid Antigen Tests over three months (a maximum of 5 in a month) will be made available free through pharmacies to people holding the following cards:

Pension Concession Card

- Commonwealth Seniors Health Care Card
- Department of Veterans' Affairs Gold, White or Orange Card
- Health Care Card
- Low Income Health Card

These free tests will become available in the next two weeks. However, anyone with COVID-19 symptoms and close contacts should attend a state clinic for free testing and not go to a pharmacy to receive a free test. Costs for providing these tests will be shared 50:50 between the Commonwealth and the States and Territories consistent with COVID shared funding agreements.

National Cabinet noted the Commonwealth will provide 10 million RATs to states and territories (a combination of predominantly Point of Care Tests and self tests) to assist with testing and laboratory capacity. National Cabinet agreed to fund these in line with the existing National Partnership Agreement on the COVID-19 Response.

National Cabinet received a briefing from Joe Buffone, Director-General of Emergency Management Australia, on behalf of the National Coordination Mechanism (NCM). Supply chain issues continue to be one of the main disruptors of broad access to RATs. National Cabinet noted that the Commonwealth is working through the NCM to finalise anti-hoarding measures with the Pharmacy Guild of Australia and other major retailers that stock RATs to limit the number of RATs available for sale to each individual.

National Cabinet noted the Commonwealth will prohibit price gouging of and the non-commercial export of RATs, similar to actions taken earlier in the pandemic relating to essential goods such as masks, other PPE and hand sanitiser. As was the case previously, price gouging will be defined as supplying or offering to supply essential goods at a price that is more than 120% of the initial purchase price (a 20% markup) and penalties for not complying with this direction will range up to five years imprisonment or \$66,000.

#### Changes to testing requirements

National Cabinet agreed changes to testing requirements for all states except for Western Australia including:


- Removing the requirement for truck drivers to have rolling seven days tests.
- Testing will not be required before patients present to hospital.
- Confirmation PCR test will not be required after a positive RAT. Individual states and territories will provide further information on how a positive RAT will be recorded. Anyone who tests positive is encouraged to contact their GP for support as required.
- Testing before interstate travel will no longer be required except for Queensland, Tasmania and Western Australia, with Queensland and Tasmania to review these requirements in the coming weeks. State test-ing clinics will not be able to be used for interstate travel purposes.
- A second post arrival test for international travelers will not be required except for Queensland, who will review this requirement when they reach 90 per cent double vaccination rate.

#### Workplace Health and Safety

National Cabinet noted the impact on business of current state workplace Health and Safety laws that could imply requiring employees to return a negative RAT test in order to present to work. National Cabinet agreed the Commonwealth Attorney General will convene a meeting of relevant ministers from all jurisdictions to consider workplace health and safety requirements with a view to removing any potential obligation to impose testing requirements in workplaces on employees

#### National Return to School Framework

National Cabinet tasked the First Secretaries Group (FSG) let by Mr Phil Gaetjens, Secretary of the Department of Prime Minister and Cabinet to develop a national framework to enable students to return to school on day one of term one, and for schools to stay open with consistent requirements across all jurisdictions to be in place prior to the first day of the first term of school. The FSG will report back to National Cabinet at the next meeting.



### New plaque honours Teddy Sheean VC

A new memorial plaque honouring Ordinary Seaman Edward "Teddy" Sheean VC was unveiled in Shropshire Park in the Tasmanian town of Ulverstone 79 years after his death.

Commanding Officer Navy Headquarters Tasmania Commander Andrew Wright represented Chief of Navy Vice Admiral Michael Noonan at the service to rededicate the memorial.

Commander Wright said Ordinary Seaman Sheean displayed incredible bravery in the action and was thoroughly deserving of Australia's highest military honour.

"Once he had helped free a life raft, allowing his shipmates to escape the sinking ship, Sheean then returned to his gun to engage the enemy," Commander Wright said. "Although wounded in the chest and back, the 18-year-old shot down one bomber and kept the other aircraft at bay as his mates made their escape."

Among the guests at the ceremony were the Tasmanian Minister for Veterans' Affairs, Guy Barnett, and Sheean family representative Garry Ivory.

Other guests included members of HMAS *Launceston's* ship's company, Australian Navy Cadets and members of the local RSL sub-branch.

The Australian Defence Force is supporting the Department of Foreign Affairs and Trade (DFAT) as it coordinates Australia's support of Tonga following the eruption of the Hunga Tonga-Hunga Ha'apai underwater volcano on Saturday, January 15.

On January 17 and 18, two Air Force P-8A Poseidon flights and one C-130J Hercules departed RAAF Base Amberley and RAAF Base Richmond to conduct aerial surveillance over the central islands of Tonga. help determine the extent of the damage, particularly in more remote locations, and inform their future disaster support requests.

While the program will formally commence in February 2022, the Secretary, along with the DVA Veteran Employment Pathways manager, Mick Barnes, welcomed Adam, Alaric, Jason, Erika and Andrew to the program early.

The Veteran Employment Pathway Program is a collaboration between DVA, Department of Defence and the Australian Public Service Commission. The program aims to support veterans into employment in the Australian Public Service (APS) including a development program to kick start their public service career. The program provides targeted support for participants' transition from a military back-ground to a career in the APS, supported by the APS Academy. This pathway has been designed to

ensure long-term success, with participants continuing in their roles as ongoing staff at DVA and Defence after completing the program.

To help participants transition to the APS culture and way of working, participants will take part in:

- formal learning and development,
- be offered a mentor,
- have access to an internal buddy,
- have access to peer networks, and
- have access to family inclusion activities.

### Joint media release — Construction begins on permanent Nowra Wellbeing Centre

Construction has begun on a new purpose built, state-of-the-art facility to permanently house the Nowra Veterans Wellbeing Centre, providing an expanded range of health and wellbeing services for our local veterans, current serving Australian Defence Force members and their families.

Minister for Veterans' Affairs and Defence Personnel Andrew Gee visited the site at 124 Wallace Street today to officially launch the building works.

"This is a momentous day for the Defence and veteran community here in Nowra and the surrounding region," Minister Gee said.

"RSL LifeCare, with the support of RSL NSW, has been doing a great job running the Nowra Wellbeing Centre out of their temporary premises and has already made a real difference in the lives of current ADF members, ex-service personnel, and their families.

"This new, permanent home will take those services to the next level. It will be a place of healing and connection, and a hub for accessing health, education and employment support.

"The facility has been carefully designed with a mix of communal, recreational and clinical spaces to meet the needs of veterans and their families.

"It is part of the Australian Government's \$43.2 million investment in a network of Wellbeing Centres across the country and demonstrates our commitment to providing local services to support veterans, defence personnel and their families wherever they live."

Senator for New South Wales Jim Molan said the new centre was a much needed addition to the region.

"The Nowra Wellbeing Centre will provide critical services to more than 7,000 local veterans and their families in the Shoalhaven and neighbouring local government areas, as well as personnel from nearby HMAS Albatross and HMAS Creswell," Senator Molan said.

"Being in the military is tough, and life after the military can be difficult to navigate. Having local support networks and a place where you can come together with others who are in a similar position is just so important."

RSL LifeCare Board Member and navy veteran Trevor Robertson said this Centre is the result of significant planning and consultation with local exservice organisations and the veteran community to deliver a one-stop shop for service delivery that is veteran-centric and community driven.

"The Nowra Veteran Wellbeing Centre will provide critical services to over 7,000 veterans and their families in the Shoalhaven and neighbouring local government areas, including education, health and ADF transition support and it will be an essential resource for the community for generations to come", Mr Robertson said.

"I would like to thank the DVA and the Federal Government for their support of the Veteran Wellbeing Centre model and RSL NSW, our partner charity, for supporting us in the delivery of services to veterans and their families."

RSL NSW President Ray James said the League has observed an increased need for support services this year and he expects this continue with the pressure or COVID-19 restrictions, the Royal Commission into Defence and Veteran Suicide, and the ADF's withdrawal from the conflict in Afghanistan last year.

"I take this opportunity to reassure veterans and their families across the Shoalhaven that local support and services are available to them at the Nowra Veteran Wellbeing Centre."

Construction on the Nowra Veteran Wellbeing Centre is expected to be finalised by mid-2022.

### **\$7.5 million for veteran wellbeing in Tasmania**

#### Thursday, 23 December 2021

The Morrison Government has today announced an additional \$2.5 million for Tasmanian wellbeing services for veterans and their families, bringing the total support for Veteran Wellbeing Centres in Tasmania to \$7.5 million.

This funding will deliver a Veteran Wellbeing Centre for Burnie and enhanced services in Launceston, as well as localised wellbeing services across Tasmania. There are almost 9,000 veterans and their families who are supported across Tasmania, with many living in the mid-north and North West of the state.

Federal Member for Bass Bridget Archer said a Federal investment of \$250,000 for the Launceston RSL Sub-Branch will further develop their existing Veterans Support and Wellbeing Hub.

### Hats off to historic family find

A piece of family military history, uncovered during restoration works at a Brisbane railway station, has been returned to its rightful owners.

During the works at Shorncliffe train station, all construction was brought to a halt as a large collection of mid-20th century objects were discovered – including a long-lost sailor's cap, dating from 1945-1950, unearthed during an archaeological dig.

Faded and tattered after being buried under the station master's building, the cap was revealed to belong to Royal Australian Navy stoker Ernest "Gus" James Hodgess.

Senior Heritage Consultant Dr Xavier Carah, of Niche Environmental and Heritage, the company engaged for the heritage work, recognised instantly that it was a Royal Australian Navy hat, and found a way to make contact with the family.

"Often when you find personal items, it's quite difficult to work out who it came from. Even with a name, it would be difficult to find the individual," Dr Carah said. "There were a few clues that helped narrow down the hunt for its rightful owner: World War II, some letters in a name and the deduction that it most likely belonged to a local on leave. A military historian reached out and said that they could help find the owner."

The family was found, and on December 2, Queensland Rail presented the hat to Gus Hodgess' son, former Navy paramedic Jamie Hodgess, who was accompanied by his nephew, Australian Army petroleum operator Warrant Officer Class Two Stuart Hodgess.

Warrant Officer Hodgess said his grandfather was a Korean war veteran. "He served on the minesweeper HMAS *Warrnambool*. It struck a mine in 1947 off the Great Barrier Reef near Cape Grenville, injuring some aboard with two dying of injuries later. My grandfather was able to swim back and forth, saving those on board. I'm very proud of him and the legacy I stand on." Before the presentation, the hat had been cleaned, stabilised and boxed by a conservator.

"This is a monumental event for not only my family, who are all ex-serving military personnel, it is also incredible to receive this in a special casing and have it back to where it belongs," Warrant Officer Hodgess said.

Unable to attend the hat presentation because of border closures, Navy Warrant Officer Paul Bodensteiner, who followed in his uncle's footsteps to join the Navy as a paramedic, said his grandfather was his inspiration to enlist.

"I was following in the footsteps of my grandfather and my uncle when I signed up. I was actually living with my grandfather when I joined the Navy in 1989," Warrant Officer Bodensteiner said."I have always looked up to him, hearing stories about when he went to sea and when he went to Korea. He never told me much about the *Warrnambool*, but when I was on the new *Warrnambool*, he opened up a little more. He kept it close to his chest. He would always get me to wear his medals on Anzac Day, even from a young age, and it's incredible to have another piece of his military history back with our family."

It is not just the family that are happy to see the sailor's hat find its way home. Dr Carah is also pleased with the outcome.

"It's very rare to get this opportunity in cultural heritage management," Dr Carah said.

"There's a desire to repatriate items to the owners or decedents of the owners. To get the opportunity to return it to its owners is remarkable. We don't often get that opportunity."

Gus Hodgess is succeeded by three generations of Royal Australian Navy and Australian Army members, including members who are still currently serving.

As for the hat, it is with Jamie Hodgess, along with other memorabilia from Gus Hodgess' Navy service.

### Rehabilitation pilot starts soon

#### 23 December 2021

The Australian Government is establishing a pilot program of Non-Liability Rehabilitation, offering eligible veterans social wellbeing and employment support – without the need for an accepted compensation claim with the Department of Veterans' Affairs.

Early access to rehabilitation can help veterans to improve their health and wellbeing. Under the new pilot program, a qualified professional rehabilitation consultant will help participants create an individual plan that aligns with their personal rehabilitation goals. The plan will last 3 to 6 months, and may include support in the following areas depending on the individual's needs:

- Social wellbeing: building new social connections in the local community
- Employment support: assistance with becoming job-ready, changing careers, or adjusting to the civilian workforce.
- Medical Management: obtaining a Medicare card or engaging a suitable General Practitioner.

The pilot commences on 1 January 2022 and is due to run for two years. An evaluation of the program's outcomes in 2024 will inform future policy design.

### Boost in support for older Australians to access Government

The Pension Loans Scheme is being renamed to the Home Equity Access Scheme, as announced recently by the Minister for Social Services, Anne Ruston.

The interest rate for the scheme is also being reduced to provide a boost in support for older Australians, including those in the veteran community.

The interest rate reduction from 4.50 per cent to 3.95 per cent per annum is great news for those considering accessing the scheme, lowering borrowing costs and allowing them to use the scheme for a longer amount of time.

The newly named Home Equity Access Scheme supports older Australians who are over the Age Pension age to access a voluntary non-taxable fortnightly loan from the Government up to a maximum value of 150 per cent of the rate of the Age Pension. The scheme allows participants to use their home as equity in order to access a loan.

To be eligible for the Home Equity Access Scheme, retirees must have reached Age Pension age, own real estate in Australia and meet residency and certain other requirements, but do not need to be receiving a pension payment.

### **New Exchange Opportunity**

Australian Defence Force Academy (ADFA) Commandant, Commodore Peter Leavy and Superintendent United States Naval Academy (USNA) Vice Admiral Sean Buck have signed a new Memorandum of Understanding to begin an exchange program for midshipmen.

The exchange program will involve six-month semester exchanges between the military academies in Canberra and Annapolis, Maryland.

Vice Admiral Buck emphasised the importance of the program in strengthening ties between the US and Australian militaries and developing cultural competence as a core enabler to future operational capability.

"The men and women of our militaries are going to serve together, and this agreement will allow them to develop the professional and personal relationships they will use throughout their career," Vice Admiral Buck said.

Commodore Leavy echoed his sentiments highlighting the importance of the exchanges in contributing to the foundational education that ADFA delivers for its trainee officers.

"We have 15 countries represented within ADFA and opportunities such as this are valuable in developing an international joint cohort amongst our midshipmen and officer cadets," Commodore Leavy said.

It is anticipated the exchange program will commence with the first four USNA midshipmen arriving in Australia to undertake six months of study at ADFA in July 2022. The first ADFA trainees are expected to travel to the US in January 2023.

"This signing is an important milestone in the academy's history. It will provide our members with an opportunity to forge personal and professional relationships at the very start of their careers," Commodore Leavy said.

"We look forward to receiving the first US midshipmen in July next year."

### Commemorating the 50th anniversary of the end of Australian involvement in the Vietnam War

#### Wednesday, 12 January 2022

The Minister for Veterans' Affairs and Defence Personnel, Andrew Gee, announced that the Australian Government has committed \$6 million to commemorate the 50th anniversary of the end of Australia's involvement in the Vietnam War in 2023.to ensure this important milestone is marked with appropriate respect and appreciation for all those who served and those who gave their lives in Vietnam.

"Australia owes our Vietnam veterans an enormous debt of gratitude," Minister Gee said. "Almost 60,000 Australians served in the Vietnam War, 521 lost their lives and more than 3,000 were wounded. We honour and remember the service and sacrifice of each and every one of them. Commemorating the 50th anniversary of the end of Australia's involvement in the Vietnam conflict will be an important opportunity for Australians to express the pride, gratitude and respect of the nation.

"The Vietnam War and its aftermath exacted a

heavy toll on all those who served and their families. The treatment of our diggers upon their return home by some of their fellow Australians remains a source of hurt and pain for many. The 50 year commemoration is another important step in helping to heal the wounds that were inflicted back in Australia.

"I will be working closely with the Vietnam veteran community to ensure the funding announced today delivers a program of events that honours all Australians who served in the Vietnam conflict.

"The centrepiece will be a national commemorative service at the Australian Vietnam Forces National Memorial on Anzac Parade in Canberra.

"We owe the men and women who served in Vietnam nothing less than a commemorative program that reflects their extraordinary service and sacrifice. Our country will always be grateful for it and we will never, ever, forget it," Minister Gee said.
